PRIVACY POLICY

Advisia inc. ("Advisia") is committed to protecting your privacy. Our Privacy Policy explains our practices, including your choices, regarding the collection, use, and disclosure of certain information, including your personal information, that are collected when you use our products and services (collectively "Information"). By using our products and services, you agree to the practices described in this Privacy Policy.

COLLECTION OF INFORMATION

Generally, we collect and store your Information to improve our products and services, communicate with you, provide customer service, tailor advertising and other types of content for you, respond to your requests for products and services, conduct research, compile statistics on the use of our products and services and provide anonymous reports for our internal use.

We do not rent or sell any of your personal information to third parties, and do not share it with third parties without your consent, unless required by law or necessary for the purpose of or provided for in this Privacy Policy.

We collect, store, use any Information that you knowingly choose to communicate and provide on any of our websites or otherwise give to us, such as your name, address your mailing address, your age, and your demographic information. You may choose not to provide certain Information, but you may not be able to take advantage of some of our products and services. You can contact us as provided in the "Contact Us" section to discuss any questions about this.

We also collect certain electronic information generated by your devices or computers when you interact with our websites, NetSign.tv software service, video players, mobile applications and our other applications and services, including where you are and your IP address. USE OF INFORMATION

We use information to provide, analyze, administer, enhance and personalize our services and marketing efforts, to process your registration, your orders and your payments, and to communicate with you on these and other topics. For example, we use information to :

- process the payment for products and services you purchase, if applicable;
- contact you regarding your account;
- track your location in order to identify the products and services that are currently available to you;
- establish your general geographic location to provide suitable content, including weather data;
- compile statistics and report on the use of its products and services;
- respond to and fulfill your requests for products and services, including to deliver the products and/or services you have purchased;
- offer you product updates and other products or services;
- authenticate users of products and services.

We must collect certain Information to provide you with the product or service you have chosen.

DISCLOSURE OF INFORMATION

We may share your information with our partners (including our service or content providers, and / or copyright holders). More specifically, we use third parties to facilitate our activities, such as payment service providers, to host services or products in a service sharing location for servers and to provide RSS content feed. As part of these operating activities, service providers may have access to the Information about you that we have collected for use for a specified period of time in connection with those operating activities. We do not authorize them to use or disclose your personal information except for the purposes of providing their services.

Please note that these third parties may be located in countries where the laws governing the treatment of personal information may differ from the laws of your country of residence.

We may also disclose Information about you when required by law or when we believe in good faith that such disclosure is necessary in order to **(a)** comply with the law; **(b)** to comply with an order of a competent judicial authority of any territory; **(c)** to comply with a judicial process served on him; **(d)** protect and defend his rights or property; **(e)** to enforce or verify compliance with any part of the agreements between you and Advisia, if any; **(f)** to prevent fraud or any other illegal activity committed through our products or services; or **(g)** act in urgent circumstances to protect the personal safety of users of our products or services or the general public.

COOKIES AND TOKENS

We record certain information using "cookies" and / or tokens. An authentication cookie or token consists of a piece of data that is stored on the user's computers or other Internet-connected devices that is linked to the user's information. We use cookies to understand the transmission patterns on our websites, our NetSign.tv software service, video players and our other applications and services. We also use authentication tokens to automatically authenticate the user when starting certain applications. We treat the personal information that cookies and tokens may contain with the same degree of confidentiality as other personal information you provide.
